

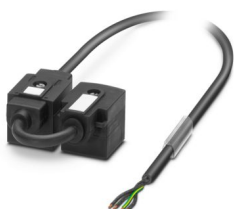

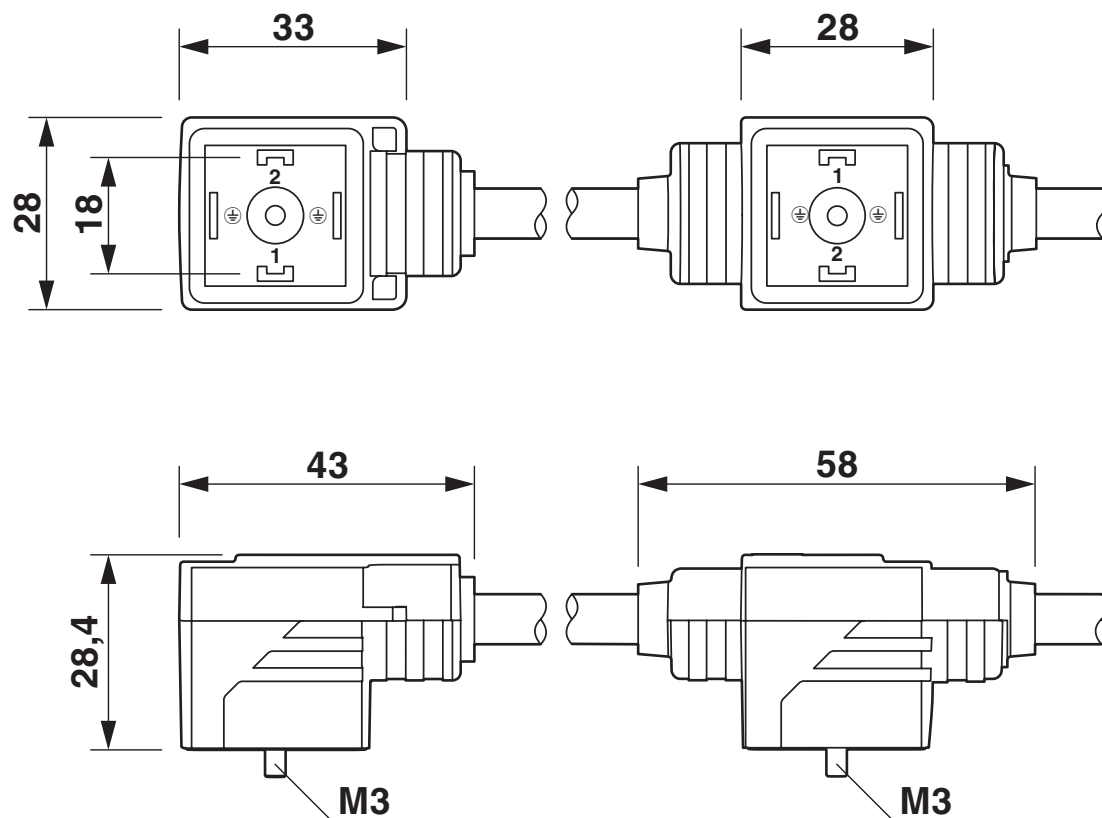

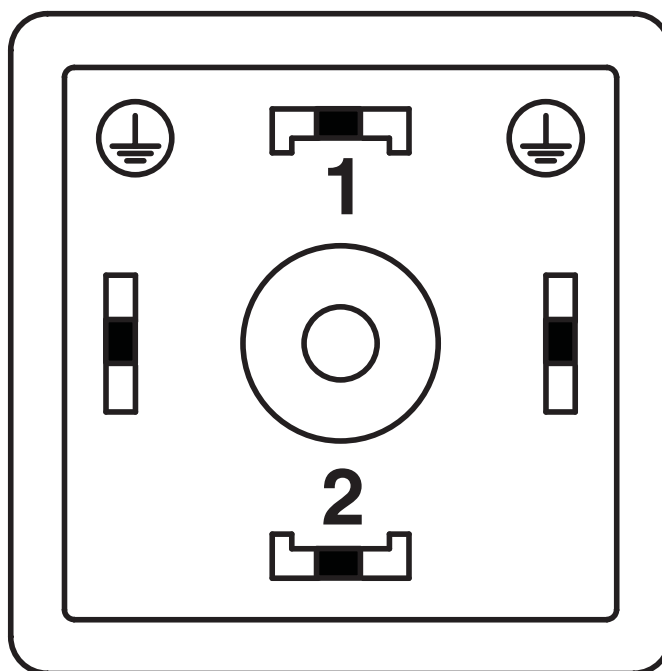

Schematic diagram



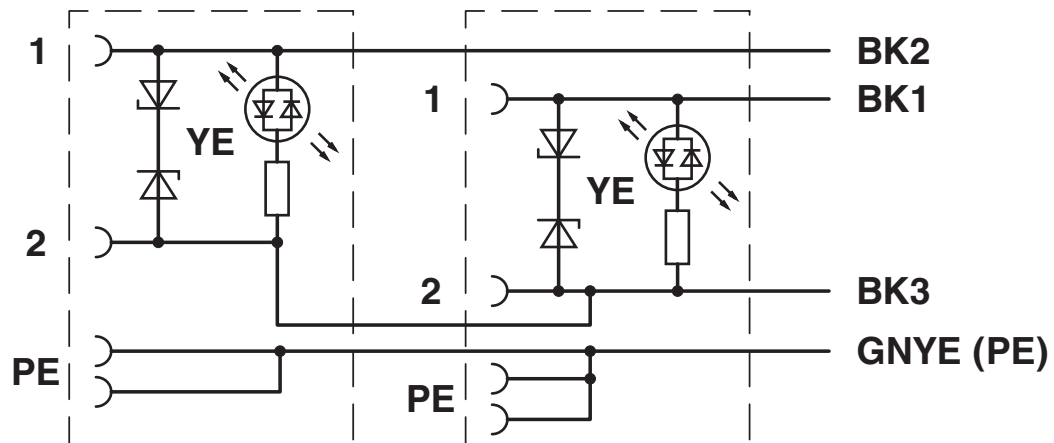
Valve connector pin assignment, type A
